Why doesn't the Chiu Bill (AB2923) apply?	Because Santa Clara County is not in the BART District. The stations are being built and will be owned by VTA.
We need to make sure Prop 6 (Revokes SB1) doesn't pass.	Comment noted.

Phase II	
Will the potholing impact side streets? When will it start?	Yes, side streets are involved. The Diridon area will be in late October and Downtown San Jose in January next year.
What is the difference between DB and DBB?	Design-Build is faster but provides less control over the final product by VTA and BART. Design-bid- build the owner get exactly what they specified but can take longer.
Will the GEC be able to bid on future work on the project?	No.
What does short-term and intermittent mean in this case?	Weekday work from 9am-5pm or for Downtown it is 9am-3pm.
Noise of this work?	It is not that noisy. The noise will be similar to a bus or a lawn mower and other ambient noise levels.
Please give us an update on the Diridon Integrated Station Concept Plan effort at the November CWG meeting.	There may not be much to report yet. We can look at the agenda to see if we have time to add a quick update.
Will there be simultaneous work? East to West?	Yes, there will be several crews, and they will be moving around the project alignment, probably 2-3 crews total.
What will happen in the Stockton area?	Utility work (pot holing/boring) north of Taylor. No geotechnical work necessary.
What is the EPD status, any update?	Staff is working with FTA. Nothing new to report yet. We are still on track to submit our Full Funding Grant Agreement application in November 2019.
Who is the GEC for Phase I?	There was no GEC for Phase I. It was all Design-Build.

Will there be geo-tagging of the investigation?	Yes, please spread the word.
