| Will VTA notify the CWG if the Santa Clara Station is a specific topic at the VTA Board Meeting? | If there is a specific station update, VTA will email the CWG. |
| CalMod Update | This update and the responses below were provided by representatives of Caltrain/JPB |
| Has installation of poles started in CEMOF and near the historic depot? | Yes, have begun installing poles, but there is more to do. |
| Are there renderings of what the poles and wires will look like? | Poles have been installed and can be viewed today at the Santa Clara Station. For each station area, Caltrain got input from Cities on pole color. |
| Phase II Update | |
| Is there any coordination with the City of Santa Clara on Newhall Yard? | Yes. When we say coordination on the station that includes Newhall Yard. The two are part of the same contract package. However, most of the yard will be in the City of San José. VTA is also closely coordinating with BART on the yard since they will operate the service. |
| Who is included in Design Review Committee? | The Santa Clara Station DRC will include members of public, CWGs, and City of Santa Clara staff. There will also be an Executive Committee with City and agency leaders. |
| For access and traffic coordination, who is leading that coordination? The City? Hunter Storm? VTA? | VTA has and will continue to coordinate with both Cities of San José and Santa Clara as well as the developer on access in and around the station area. |
| Will VTA have a follow-up construction access meeting with PayPal Park? If so, what are the next steps? | Yes, we will continue to coordinate with the San Jose Earthquakes throughout the project. Once the design-build contractors come on board and they've determined their means and methods, they will each develop a Final CTMP for each contract package. We will have our next meeting on construction access once the design build contractor for CP2 is on board. |
| Are micro-mobility services, such as electric bikes and scooters, part of the station design? | Yes, there is consideration for micro-mobility. VTA will be providing space as the City of Santa Clara is moving back towards having micro-mobility. The City is re-evaluating its policies now, and VTA will coordinate so design adheres to their policies. |
